

UK IMPORTS AND EXPORTS construction and earthmoving equipment Q2 2024




Summary


Imports and exports of construction and earthmoving equipment both recorded increases in Q2 compared with the first quarter of the year. After being on a steady downward trend last year, imports showed an increase in Q1, and this continued in Q2. This recovery has taken levels of trade back to the high levels seen in 2022 and the first half of 2023. In contrast, exports of equipment in the second quarter were still below 2023 levels. However, they were still at very high quarterly levels in the first half of the year, well above the levels of trade seen in the previous ten years from 2013 to 2022. The graphs below show UK imports and exports since 2013 based on both the weight of equipment shipped (tonnes) and the £

value traded.

Imports

In Q2, imports of equipment showed an 18% increase in tonnage shipped, a similar level of increase as seen in Q1. This took imports to just under 98 k tonnes in the second quarter. In value terms, trade also showed a significant increase at 19% above Q1 levels to reach £718 million. Increasing levels of imports in the first half of the year is consistent with the improving levels of UK sales of equipment this year, after being on a downward path in the second half of 2023. UK sales of equipment are taken from the UK construction equipment data exchange published by Systematics International. The EU share of UK imports is shown in the table below and is remaining just above 70% this year. This is continuing at the level seen since the second quarter of last year, which was higher than previous years.

Exports

Exports of equipment in Q2 showed a pick-up on Q1 levels for both tonnage shipped and value of shipments. Tonnage shipped increased by 2% in Q2 to reach over 197k tonnes, while the value of exports showed a 3% increase to reach £1,185 million. As highlighted above, exports in Q2 were still below the quarterly levels seen in 2023, but were still at very high levels - well above the levels of trade seen in earlier years between 2013 to 2022. The share of export trade to EU markets is shown in the table below and indicates the continuation of a slight downward trend. The EU share of total exports of equipment remained at 40% in the first half of the year, compared with 41% last year and 44% in 2022.

Overall, the UK has remained a significant net exporter of construction and earthmoving equipment in the first half of 2024, with exports (£2,333million) 76% higher than imports (£1,32202 million). However, this is lower than the 87% level recorded in 2023.

Exports of equipment by country of destination

In the first half of 2024, UK exports of construction equipment were shipped to over 160 different countries. The table below shows rankings for the Top 20 countries based on weight of machines shipped (tonnes) during 2023 and 2024. In the first six months of 2024, the Top 20 countries accounted for close to 85% of total exports on both a value and tonnage shipped basis. The USA remained as the top destination for UK exports in the first half of 2024, recording a share of 37.5% of total exports on a £ value basis. This was well above the 32% level reached in 2023. Based on tonnage shipped, the USA share was just under 28% in the first half of the year, also ahead of 2023 levels at 26.5%.

Ireland remained in second place in the country rankings, with a 9% share on a tonnage shipped basis. This was just ahead of Poland which is continuing to show growth as an export destination in recent quarters and has reached a share of 8% of total exports in the first half of the year. The Netherlands maintained its position in fourth place in the rankings and the top four countries continued to account for over half of total exports in the first half of the year. This was just under 52% based on tonnage shipped, and 53% based on the \pounds value of exports.

Imports of equipment by country of origin

IIn the first half of 2024, UK imports of construction and earthmoving equipment arrived from over 60 different countries. The table below shows rankings for the Top 20 countries based on weight shipped (tonnes) during 2023 and 2024. In the first half of this year, the Top 20 countries accounted for between 96% to 97% of total imports in both weight and value terms.

Imports from China continued to show significant growth in Q2 compared with last year and it remains ahead of the Netherlands as the leading source, after being in fourth place last year. This is on a tonnage shipped basis and has reached 17% of total imports on this basis. Based on the value of equipment imported, Germany remained as the leading source in the first half of the year, ahead of the Netherlands and Belgium, with China in fourth place. Imports form Japan are remaining at lower levels this year and it stayed in sixth place in the rankings after six months, based on tonnage shipped, after being in second place in 2023.

Definition of equipment included in analysis of import and export statistics

The data used in this report is taken from HMRC official trade statistics, covering construction and earthmoving equipment (excluding separate trade data for components and parts). Trade data has been used from nine different HS codes, consisting of the following at the four digit level:

- 8413 concrete pumps
- 8426 cranes
- 8474 crushing and screening equipment, and concrete, mortar and other types of mixers
- 8479 machinery for public works
- 8701 track-laying tractors
- 8704 dump trucks for off-highway use
- 8705 concrete mixer lorries and pumping vehicles
- 8429 construction and earthmoving equipment including bulldozers, graders, scrapers, loaders, excavators, shovels, tamping machines and road rollers
- 8430 pile driving and pile extracting equipment, tamping and compacting machinery.
